#### **Minimum Monthly Operating Expenses:**

This includes rent (\$499.09), insurance (\$70.37), bank fees (\$3.75) + incidental expenses (\$76.79) = \$650.00. This does **not** include money for supporting our programming. It is the bare minimum amount for operating expenses.

#### **Cash Reserve**

For well over a year our bank balance has not dropped below **\$1950**, which represents operating expenses for a 3 month period. Maintaining a \$1950 cash reserve gives us a grace period of **3 months** in which to find additional funding in case we discover that we will not receive hoped-for funding.

Cash that May Not Be Used for Operating Expenses: \$3416.80 This includes money ear-marked for the Aging with Pride Committee, and the TMMC Sponsorship of six

student bursaries. As of 2016, July 31, this amount was \$416.80 (AwP) + \$3000 (TMMC) = \$3416.80

#### We can Keep Our Doors Open:

Until about 2017, January 31 if we maintain a \$1950 cash reserve and support SPECTRUM's programs.

Until about 2017, April 30 if we use up the \$1950 cash reserve and support SPECTRUM's programs.
